## Overview

The National Provider Identifier (NPI) is a unique identification number for covered health care providers, a simplification standard specified by the Health Insurance Portability and Accountability Act (HIPAA) Administrative to improve the efficiency and effectiveness of the electronic transmission of health information. Covered health care providers and all health plans and health care clearinghouses will use the NPIs in the administrative and financial transactions adopted under HIPAA. Covered providers must share their NPI with other providers, health plans, clearinghouses, and any entity that may need it for billing purposes.

The NPI is a 10-position, intelligence-free numeric identifier (10-digit number). This means that the numbers do not carry other information about healthcare providers, such as the state in which they live or their medical specialty. Beginning May 23, 2007 (May 23, 2008, for small health plans), the NPI must be used in lieu of legacy provider identifiers in the HIPAA standards transactions. Covered entities may invoke contingency plans after May 23, 2007, and guidance about contingency plans may be below.

If you are a health care provider who bills for services, you probably need an NPI. If you bill Medicare for services, you definitely need one. If you delay applying for your NPI, you risk your cash flow and that of your health care partners as well. The Centers for Medicare & Medicaid Services (CMS) has developed the National Plan and Provider Enumeration System (NPPES) to assign these unique identifiers.

## Applying for an NPI

When applying for your NPI, CMS urges you to include your legacy identifiers, not only for Medicare but for all payors. If reporting a Medicaid number, include the associated State name. This information is critical for payors in the development of crosswalks to aid in the transition to the NPI.

Health care providers who participate in a group practice, or are organizational providers, should coordinate with their organization to determine the appropriate time for NPI application.

### ***Health care providers can apply for NPIs in one of three ways***

- For the most efficient application processing and the fastest receipt of NPIs, use the web-based application process. Simply log onto the National Plan and Provider Enumeration System (NPPES) and apply on line at <http://nppes.cms.hhs.gov>.
- Health care providers can agree to have an Electronic File Interchange (EFI) organization (EFIO) submit application data on their behalf (i.e., through a bulk enumeration process) if an EFIO requests their permission to do so. See the EFI section below.
- Health care providers may wish to obtain a copy of the paper NPI Application/Update Form (CMS-10114) and mail the completed, signed application to the NPI Enumerator located in Fargo, ND, whereby staff at the NPI Enumerator will enter the application data into NPPES.

## **EFI**

EFI is a “bulk enumeration” alternative to health care providers having to apply for their NPIs via the web-based or paper application process. After the National Plan and Provider Enumeration System (NPPES) processes a file, it makes available to the organization a downloadable file containing the NPIs of the enumerated health care providers. Interested health industry organizations should avail themselves of the EFI materials available on this page and from the NPPES page before downloading and completing the Certification Statement (available at the NPPES page) and registering as EFI Organizations. A completed Certification Statement must be approved by CMS before an interested health industry organization can participate in EFI.

- **EFI User Manual** – This manual provides step-by-step instructions on how EFI works from a systems perspective including screen prints, screen descriptions, etc., that show how EFI actually operates in practice.

## **Guidance on Compliance with the HIPAA NPI Rule After the May 23, 2007 Implementation Deadline**

### **Background**

All covered entities must be in compliance with the NPI provisions by May 23, 2007, except for small plans, which must be in compliance by May 23, 2008. Compliance means in part that the NPI must be used by covered entities to identify providers on all HIPAA covered transactions that call for health care provider identifiers. Covered transactions that require a health care provider’s identifier that are transmitted containing only legacy identifiers (identifiers in use today) or containing both legacy identifiers and NPIs would be noncompliant.

### **Enforcement Approach**

The Administrator of the Centers for Medicare & Medicaid Services (CMS) has authority to enforce the electronic transactions, code set, security, and identifier provisions (i.e., non-privacy administrative simplification provisions) of HIPAA. CMS will focus on obtaining voluntary compliance and use a complaint-driven approach for enforcement. When CMS receives a complaint about a covered entity that

appears to allege a failure to comply with a non-privacy administrative simplification provision of HIPAA, it will notify the entity in writing that a complaint has been filed.

Following notification from CMS, the entity will have the opportunity to 1) demonstrate compliance, 2) document its good faith efforts to comply with the standards, and/or 3) submit a corrective action plan.

## **Good Faith Policy**

CMS's approach will utilize the flexibility granted in section 1176(b) of the Social Security Act to consider good faith efforts to comply when assessing individual complaints. Under section 1176(b), HHS may not impose a civil money penalty where the failure to comply is based on reasonable cause and is not due to willful neglect, and the failure to comply is cured within a 30-day period. HHS has the authority under the statute to extend the period within which a covered entity may cure the noncompliance "based on the nature and extent of the failure to comply."

During the 12 month period immediately following the May 23, 2007 compliance date for all covered entities other than small health plans, CMS intends to look at both covered (non-small health plans) entities' good faith efforts to come into compliance with the NPI standards in determining, on a case-by-case basis, whether reasonable cause for the noncompliance exists and, if so, the extent to which the time for curing the noncompliance should be extended.

For a 12 month period after the compliance date (i.e., through May 23, 2008), CMS will not impose penalties on covered entities that deploy contingency plans (in order to ensure the smooth flow of payments) if they have made reasonable and diligent efforts to become compliant and, in the case of health plans (that are not small health plans), to facilitate the compliance of their trading partners. In determining whether a good faith effort has been made, CMS will place a strong emphasis on sustained actions and demonstrable progress. A covered entity may end its contingency plan at any time prior to May 23, 2008, but cannot continue it after that date.

Indications of good faith might include, for example, such factors as:

- Increased external testing with trading partners.
- Lack of availability of, or refusal by, the trading partner(s) prior to May 23, 2007 for health plans (other than small health plans) to test the transaction(s) with the covered entity whose compliance is at issue.
- In the case of such a health plan, concerted efforts in advance of the May 23, 2007 and continued efforts afterwards to conduct outreach and make testing opportunities available to its provider community.
- For a health care provider, having obtained an NPI and having the ability to use it on HIPAA transactions.

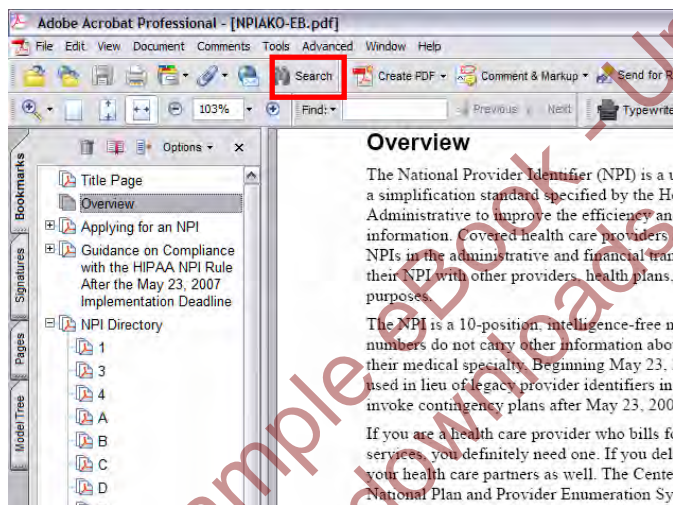
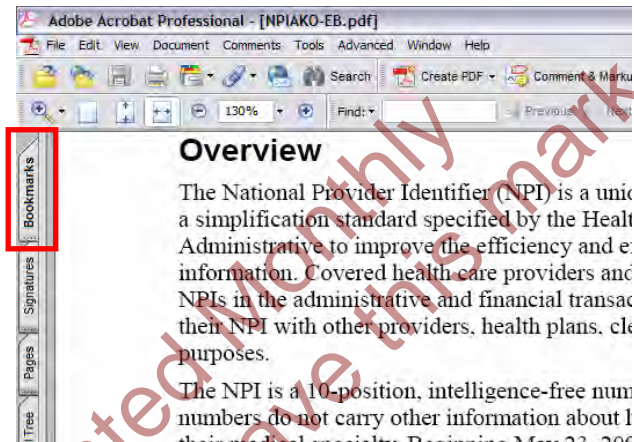
CMS might examine whether the health plan undertook a course of outreach actions to its trading partners on awareness and testing, with particular focus on the actions that occurred prior to the May 23, 2007 NPI compliance date. Similarly, health care providers should be able to demonstrate that they took actions to become compliant prior to May 23, 2007, including obtaining an NPI. If CMS determines that reasonable and diligent efforts have been made, the cure period for noncompliance would be extended at its discretion. Furthermore, CMS will continue to monitor the covered entity to ensure that their sustained efforts bring progress towards compliance. If continued progress is not made, CMS will step up their enforcement efforts.

# How to Use this NPI SpeedEBook™

To improve your searching experience with the NPI SpeedEBook, we offer a few hints. The images below are from Adobe® Acrobat® Professional 7. If you would like to download the latest free Reader product from Adobe visit <http://tinyurl.com/a9sbq>.

- 1) The SpeedEBook is created with PDF bookmarks. To search the quickest, you want the Bookmarks display open. The Bookmarks tab is to the left of your document viewing window lying vertically on the side of the page, shown in a red box in the image to the right.
- 2) Click the Bookmarks tab to open the bookmark list. Click the individual bookmarks to navigate to specific document sections.



- 3) If you are searching for a particular provider, click the number, letter or letter combination that starts the provider's last name or organization name. Then either scroll through the pages to find the provider, noting the range of names in the top outer corner of the page, or click the Search button shown to the left in a red box. A search starts from your location in the document so by using the bookmarks to find the first letter, the search is much quicker. If you do not see a Search button, you can also type Ctrl+F on your keyboard to open the search.

- 4) If you want to find a provider by NPI or UPIN, you can simply start a search the beginning of the SpeedEBook. In addition, there are two

bookmarks at the bottom of the bookmark list. The NPI Index lists each provider's NPI in numerical order and includes the provider's UPIN. The following UPIN Index lists the UPINs in order and the accompanying NPI. These indexes let you crosswalk between NPIs and UPINs without having to look up the provider entries.
